- 1. All extinguishers should be tested and refilled in every year and certificate is to be pasted in the body of the extinguishers.
- 2. Electric line/meter box should be checked with registered Electrician and proper maintenance should be made, if necessary.
- 3. Always main gate is to be made free and should engage a person for maintenance of the gate.
- 4. Always underground and overhead reservoir should be filled up with water. A stand by pump is to be activated and the persons for operating pump should be engaged.

- 5. Good housekeeping should always be maintained.
- 6. All the staff members should have the knowledge to operate the Fire extinguishers accordingly and they should always be aware of installed fire safety measure as incorporated in the building.
- 7. A trained Fireman shall be maintained round the clock for fire safety of the building.
- 8. Fire License shall have to be obtained for proposed storing and processing with L.P.G. and other highly combustible articles.
- 9. The interior decoration of the building shall be made with low flame spread material confirming to the I.S Specification.
- 10. A fire control room including a close circuit TV system shall have to be maintained which observe all the floors of the
- 11. Mock fire practice and evacuation drill shall be performed periodically with participants of all the occupants of the buildings.
- 12. The fire safety audit to be conducted at regular interval and to be recorded in the fire prevention register.
- 13. The notice of fire fighting and evacuation from the buildings shall be prepared and displayed at all vulnerable place of the buildings.
- 14. Electrical ducts shall have to be sealed vertically and horizontally in proper manner immediately
- 15. Fire Safety certificate shall be renewed in 3-(Three) years from the date of issue after comprising safety installations are in working condition.
